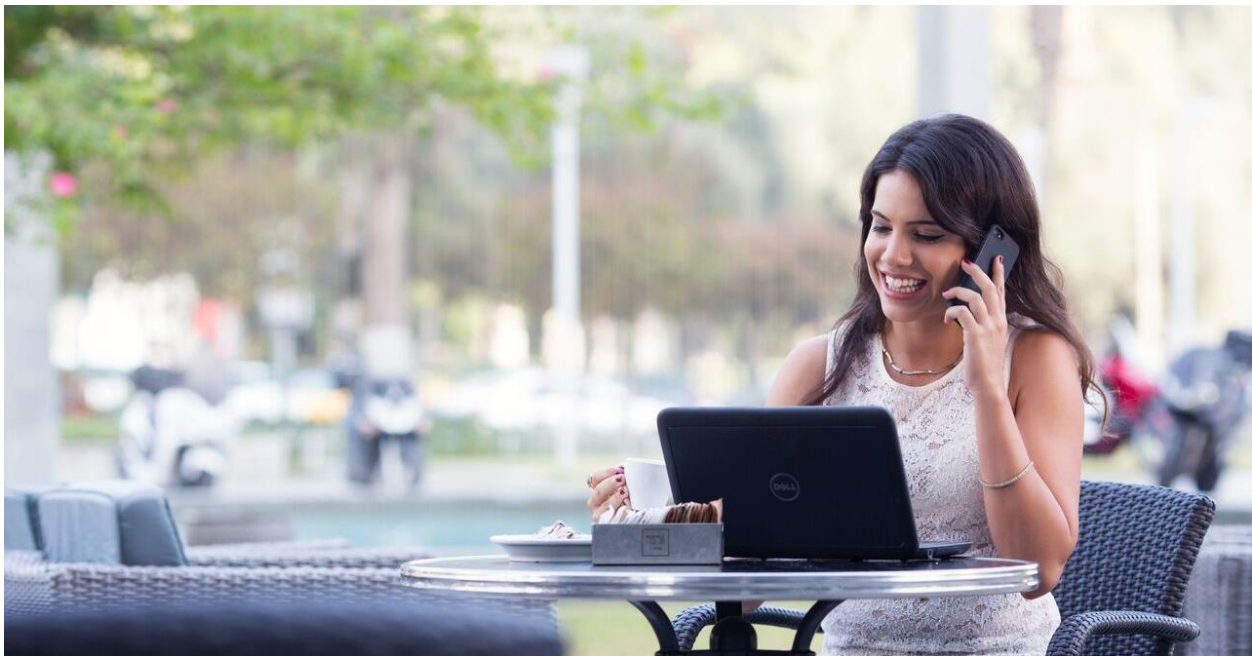

Going Self-Employed Means More Responsibility

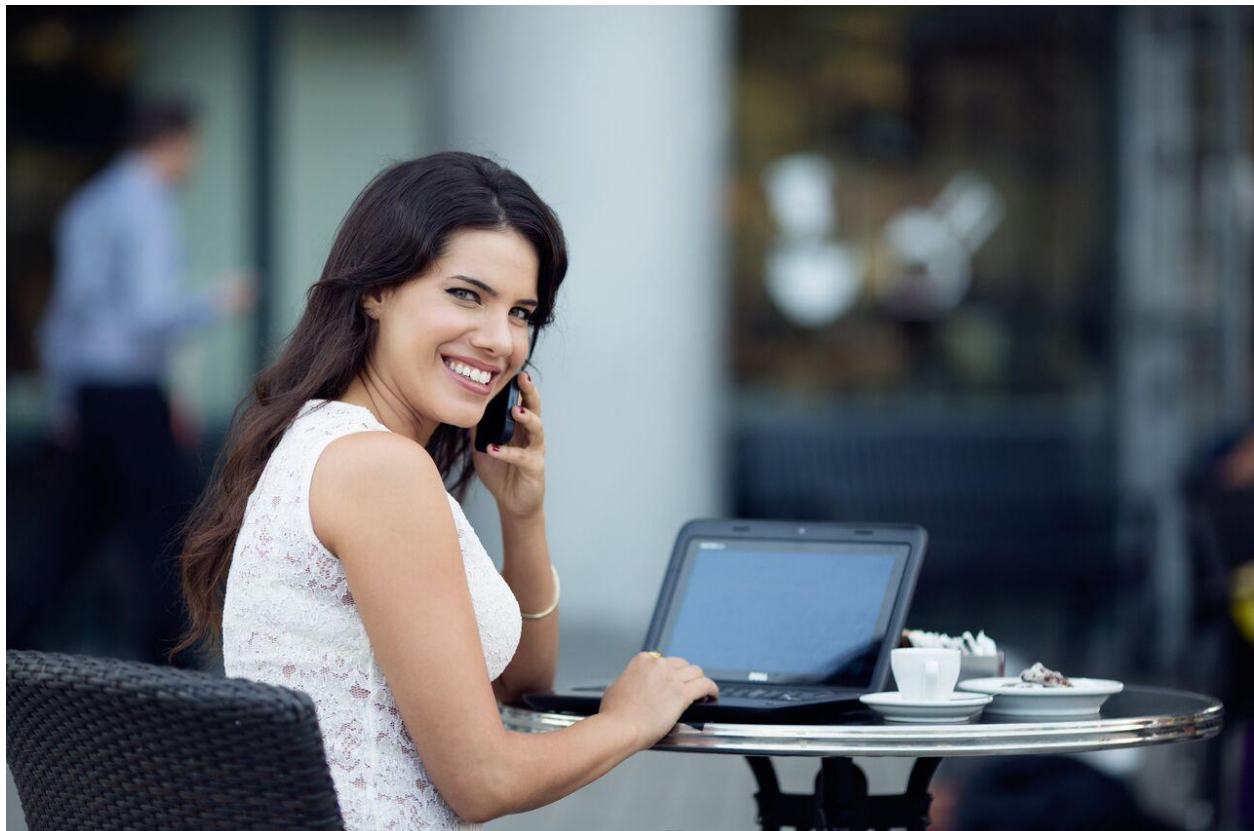

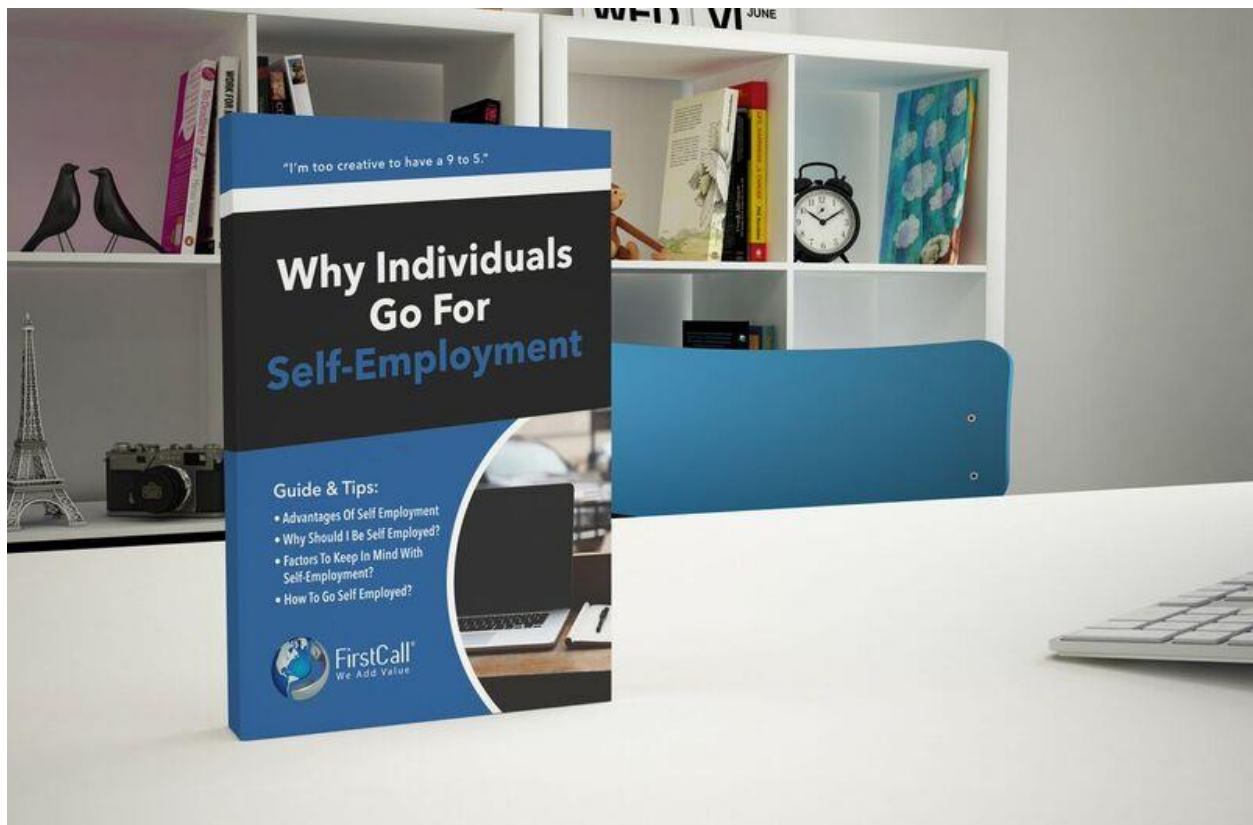
You Need To Define Self-Employment
